CALL TO ORDER

Warden Roulston called the meeting to order at 7:03 p.m.

LAND ACKNOWLEDGEMENT

Warden Roulston respectfully acknowledged that East Hants is in Mi'kma'ki and the District of Sipekne'katik, the ancestral and unceded territory of the Mi'kmaq people. East Hants further acknowledges the 50 African Nova Scotian communities whose 400-year history have contributed to the provinces culture, history and legacies. We are all Treaty people.

ITEM #61 - REQUEST REGARDING STREET SWEEPING AND GRASS CUTTING - COUNCILLOR TINGLEY

C24(241) On motion of Councillors Tingley and Isenor:

[3:00]

Moved (later defeated) that staff bring back a report to council explaining rationale for an acceptable street sweeping standard in the corridor area and recommended steps MEH can and should take to achieve the standard.

Discussion ensued, and centered on the limited scope of the motion, as this is an issue for the entire Municipality, and the role that construction projects and businesses could play in keeping the streets clear of debris. Some Councillors noted that NS Public Works has set standards for road maintenance and wondered if this was a good use of staff resources.

MOTION DEFEATED

Nine (9) voting against and two (2) voting in favour; with Councillors Tingley and Isenor voting in favour.

C24(242) On motion of Councillor Tingley and Isenor:

[15:00]

Moved (later amended) that staff write to the MLA or the Minister of Public Works, or whoever the appropriate person is at NSPW to request that they maintain their grass areas in the Corridor area more frequently and to the standard that the Municipality maintains their grass, and that staff enclose photographs depicting the current condition of NSPW grass in the corridor area.

CAO and the mover clarified that the letter could be addressed to the Area Manager of Public Works and cc the MLA. The Seconder approved.

Discussion ensued, and focused that this issue is not localized to the Corridor and the address of the letter.

C24(243) On the motion of Councillors Perry and Tingley:

Moved to amend motion C24(242) to reflect the grass standards on all major Provincially owned trunks and routes in East Hants.

Discussion continued, including limited resources of NS Public Works.
