Warden Roulston called the meeting to order at 7:00 p.m.

LAND ACKNOWLEDGEMENT

Warden Roulston respectfully acknowledged that East Hants is in Mi'kma'ki and the District of Sipekne'katik, the ancestral and unceded territory of the Mi'kmaq people. East Hants further acknowledges the 50 African Nova Scotian communities whose 400-year history have contributed to the provinces culture, history and legacies. We are all Treaty people.

The Warden further acknowledged the beginning of Truth and Reconciliation Week and East Hants has raised the Survivors Flag at the Lloyd E. Matheson Centre to recognize and honour the survivors of residential schools, their families and the children who never returned home. The flag will remain flying until the end of October.

Staff addressed questions from Council with respect to open space for the development, lift station upgrades and cost-sharing for upgrades, resident worries that the development will make the flooding worse, storm water management, ditching, the process of stormwater plan approval. [34:00]

Warden Roulston asked if the applicant had any comments or would like to make a presentation.

John Paul Cyr, Applicant:

- The applicant acknowledged that Shubenacadie is prone to flooding problems, but that they are working with engineers and hope that if the road is upgraded that will help the issue, and if they need to add a retention pond they will.
- The applicant believes that he is the first developer to work in Shubenacadie in several years because of the moratorium on development; if Council and the community wants to expand, they need to work with developers.
- The applicant noted that he is experienced enough and wants to do his best for the community.

PUBLIC COMMENTS/QUESTIONS

Warden Roulston opened the floor for comments and questions from members of the public in attendance.

John van de Reit, owns property near the subject site [56:00]

- Questioned if the development would push the lot total past 100 if the 47 lots were subdivided

Nicola MacLean - 19 Havenwood, Shubenacadie

- States she has been personally affected by the flooding on Havenwood and that her family is very diligent about checking their ditches
- Can residents be interviewed or involved in drafting the storm management plan? Have there been studies or research on flooding in the area? Has the McInnis Trail been checked? Concerned about the location of the new houses, because there is an unofficial retaining pond that she does not want impacted

Staff encouraged residents to reach out to municipal engineering staff or the applicant with concerns and additional information. The road is owned by the Province of Nova Scotia; any upgrades required would need to be done by the road owner. Flood mitigation studies have not been done by the Municipality.

John van de Reit

- How to do quantify existing flooding issues?
- As developer sells and subdivides, once it hits 100 lots, does it stop, or can he keep subdividing?
- What is the difference in elevation from bottom to top of plan?

Staff explained that no more than 100 lots will be approved as per policy and the elevation is unknown at this time. The development will have to comply with municipal standards.

Warden Roulston asked if there were any questions or comments via YouTube Chat. There were none.

Warden Roulston asked if staff had any final comments. There were none.

Councillor Rhyno noted that the Maitland Fire Auxiliary would like to install an electronic (internally lit) sign but it is not permitted in the Heritage District or the RU2 zone, with the exception of those that have been grandfathered, which feels unfair.

HARDWOOD HERBICIDE SPRAY

Councillor Rhyno has received a complaint from a resident that has a cottage on Cedar Road. The complaint was that an ariel spray that is used to kill hardwood in the forest left a very bad odor. Councillor Rhyno subsequently learned that a permit can be obtained from the Department of Environment to use this spray but only on private land, not on Crown land. He raised concerns that this spray will have an effect on the wildlife.
