## Good Morning,

More than ever, the public is recreating outside enjoying skating, skiing, and sledding during the winter months. When they do so on public lands, the owner (the municipality) is responsible for ensuring that the play areas are as safe as possible and free of potential hazards.

The owner of the property, as the occupier, has responsibility for safe play to all individuals who enter their property, whether invited or not. Municipalities must conduct reasonable inspections of all property to confirm that the property is safe, secure, and without known hazards.

Sledding and ice skating are two popular activities that occur on municipal lands during the winter months. As the seasons change and winter approaches, municipal units are encouraged to consider the risks that these activities pose to residents and to the organization.
